Pursuant to due call and proper notice thereof, a meeting of the Breckenridge City Council was held on July 1, 2024, at 5:00 p.m., City Hall Council Chambers, Breckenridge, Minnesota.

Members Present: Mayor Russell Wilson; Council Members Beth Meyer, Evie Fox, Reed Johnson, James Jawaski, Chris Vedder and Scott Wermerskirchen. City Administrator Lori Conway and City Attorney Jason Butts.

Members Absent: None.

Mayor Wilson called the meeting to order at 5:00 p.m.

Council Member Johnson moved to approve the agenda. Seconded by Council Member Jawaski and carried unanimously.

Open Discussion:

Mark Goldberg from David Drown Association went through the Salary Study that was
updated from the one performed last year. They sent out requests to 27 different cities
and received about 2/3 of them back. They only used the ones which the JET survey
description was 80% similar, the others were thrown out. Only the duties are looked at,
not the actual specific employee in that position.

With the new proposed schedule, it puts the City within a 3.4% margin of the market in regards to the minimums and .52% of the maximums. It has 11 grades being 5% apart from each other and 9 steps with each being 3% apart. It lists 4 positions as being overpaid which will only give them a 1% increase next year if adopted. The ones that are underpaid will receive up to a 5% to get them up to speed. The budget increase for all employees will be a 2.4% increase.

Cayden Barta asked why many of the positions pay went down from the last survey that was done. Mr. Goldberg said they didn't but he didn't have the previous survey in front of him to look at.

Motion by Council Member Johnson to accept the wage study from David Drown Association as presented. Seconded by Council Member Vedder and carried unanimously. City Attorney Butts reminded the Council that the if the bargaining units do not accept the study and a contract is not agreed upon, this study will become effective January 1st.

Motion by Council Member Meyer to approve the Consent Agenda. Seconded by Council Member Fox and carried unanimously. The Consent Agenda included the following:

Red River Valley Water Supply Project (RRVWSP) – Neil received the dollar amounts of what it is going to cost the City to participate in the project. Not sure of what the City will be getting for the money that would spend. 85% of the benefit will be for the Grand Forks and Fargo areas. Wahpeton has many of the same questions so another meeting will need to be set up with the RRVWSP prior to a decision being made to participate in the project or not. A July 31st deadline has been set to sign the Memorandum of Commitment so the meeting will need to be prior to that.
