5. New project- discussion

a. Jefferson Park-sidewalk & playground

b. Levee path

- -Neil has talked with the Public Works Committee, Wilkin County, the golf course manager and Wahpeton Director of Public Works regarding adding a paved path onto the levee between the golf course walk bridge and River Bend Trail, along the Golf Course. All communication has been good, and they feel that it is a good idea. Upholding the levee is the responsibility of the city and with the current use of this path, there is show of wear. There will need to be some maintenance on this levee very soon and a paved path will only help with the structure's integrity.
- -Discussion was had regarding grant options and the possible issue of this being a shared path with motorized vehicles.
- -Grant opportunities will need to be looked into for this project, due to the large cost.

d. Other

i. AARP Community Challenge Grant - opens January

- -Lori watched a webinar on this grant opportunity and included a few of the slides (timeline, scoring criteria and grant categories) and examples of projects that were awarded in the past.
- -Committee discussed a few of the options for this grant, including community gardens and adding additional pickleball courts.
- -The committee decided that with the current use of the pickleball courts and the age group (older community) that uses them that this grant should be written for an additional 2 courts to be painted, poles, nets and separation fences.

- -Sarah has volunteered to write the grant. Neil will get a quote and help with the background on the project. Lori can get any photos of the current courts, if needed. Patrick has offered to write a letter of support from PartnerSHIP 4 Health.
- -The grant is due March 5th at 5pm.

ii. BCSC Wellness Grant - Fitness Court

The mayor received an email from a representative for a National Fitness Campaign regarding an outdoor fitness infrastructure through a partnership with a state sponsor grant from Blue Cross Blue Shield. The committee discussed having this outdoor equipment in our community and decided that with the weather in this area, the future maintenance and the potential cost factor, we are not interested in this project.

iii. Booth at Older Adult Resources Fair

The committee was asked to have a table to promote the ALC at an Older Adult Resources Fair on April 11th at the Breckenridge Senior Citizen Center from 9am-2pm. The committee discussed and there is no one that is available to be at the booth. However, Sarah will be at a booth for her work (CHI St. Francis) and is willing to have some brochure to hand out. Lori will get her some ready for that day.

<u>Other</u>

-Jen asked the committee, as a new member, why we seem to be so focused on the outdoors with the climate that we live in. Shouldn't we be looking into having an indoor space? Her thoughts would be to have a building with a walking path, equipment for children, fitness equipment for adults, etc. The committee discussed the status of The Infinity Center and The Children's Discovery Center, both of which these will have the items listed above.
